HEN Ron Martin rose from his seat with 10 minutes left of the Boston fright night and descended from the rear of the directors' box for 'a word' into the Blues dugout, it was clear he had not gone walkabout with the intention of offering the isolated figure of Steve Wignall an on-the-spot contract extension.

In fact, as the West Bank offered us the dulcet tones of their rendition of 'We Want Wignall Out, Said We Want Wignall Out', slim odds were already being offered on our latest boss once again joining the lengthy queue at the clearing house for out-of-work managers before many more moons were up.

What a turnaround, though. We may still be 22nd in the Third Division and up against one of the most desperate situations SUFC has faced since Anton Johnson was raiding the Christmas Club cash back in the halcyon days of the mid-80s. But, as ever, we battle on – a mere three months off Two Jags' verdict on Fossetts Farm!

Wiggers keeps saying he will turn it around. Let us just hope we can finally stop asking 'When?' and cease having to suffer the grim fare placed before our disbelieving eyes far too frequently of late. Unbeaten in four away, Monsieur W claims the players have become scared of playing at the Hall. Why, when everyone is willing them on to do well? Just cut the excuses and show us what you can do – week in, week out. Because if 22nd is it, God help us.

The Kidderminster win was supposed to be the galvanising force for the upward push we have all been praying for. Instead we got the exact opposite and gifted three points each and a massive lift to two of our bitterest rivals in the Third Division mire. The marvel of Moss Rose really must become the true turning point.

HE SUSCT will certainly keep plugging away, doing its level best to keep fans behind the side and trying to hang on to the record number of members it has worked so hard to attract. Yet a successful Trust relies heavily on a successful team. Nothing else will do.

And what an added incentive the lads now have. Despite their sad reluctance to get properly involved in Quid A Goal on a realistic basis, the opportunity is there for the squad to land a nice little earner by the season's end. All they need to do is start showing us the form of which they claim to be capable and hit the positions in the table that

will mean an escape from the clutches of Division Three. And I don't mean 23^{rd} or 24^{th} ! For a group of committee men who should be of sounder mind and know better have cobbled together £300 that was plunged on Blues eachway at 1000-1 prior to the Orient agony for us still to finish 1, 2 or 3 this season. After the Boston nightmare we could probably have got 5,000-1, but no matter. If the business was done and the title taken, there would be a cool £180,000 in the pot. Half for the bet brigade, 25 per cent for the Trust and 25 per cent for the players. So there is a £45,000 carrot for the lads (though only £9,000 for second or third) to begin showing us what they are really made of . Because if the majority of what we have been seeing of late is it, then the big derby we end up looking forward to next season will not be against C** U, but......Canvey Island in the Conference!

Talking of cash, I take it everyone received their AGM / Trust Financial Statement / Christmas Draw tickets pack. By the time you read this (assuming you do) only the draw tickets will still be relevant. And, as always, I am simply going to chant the same old mantra. Please EVERYONE – and that does mean YOU – do your best to sell your tickets and return the stubs to <u>Terry Jeffreys (either in person or at 32 Herondale, Basildon, Essex. SS14 1RR) or Richard Coxell (either in person or at 20 Redcliff Drive, Leigh-on-Sea, Essex. SS9 1AY) well in time for them to be entered in the drum for the £1,000 first prize at half-time v Oxford on December 28. This is a major Trust fund-raiser and lets you to do your little bit and feel even better about yourself than usual. Blues looked a lot more solid all round and better organised, especially at the back. Apart from that there was the added entertainment of the first on-board quiz, all arranged pre-departure by Alan Perry and superbly won by Gerry Smith with 24 correct answers out of a possible 25. He paid £1.5million for the land and about £17million to build the stadium – and added that our big problem was having property developers involved rather than a stand-no-nonsense, one-man band like himself. Surely not. George, of course, is something of a rarity – a crook who reformed before he came into football, rather than a businessman who became a crook once he got into football. Where is the philanthropist to take us to the promised land?

SOUTHEND 1 HUDDERSFIELD 2 (4/10/03): A result to make grown men cry. If they awarded points for pressure, we would have had three sewn up. Sadly, they don't. Sticking the ball in the net is all that counts and we just do not look capable of doing that often enough. Once again, after taking a 43rd-minute lead through Leke Odunsi's neat 18-yarder we allowed the visitors to level right on half-time. Then, after a spell of late second-half pressure which saw us do just about everything bar score, they hit us with a devastating break. Kevin Maher failed to catch scorer Danny Schofield, who avoided our skipper's last-gasp bid to trip him and tucked the ball past Darryl. A massive blow to morale, both for Blues players and fans like Mr G and Mr I on their return to the home of their first love. The fact the team was applauded off showed the faithful knew the lads had given it their all and did not deserve to lose. We know we are better than second-bottom, but that is where this result dumped us. Plus, the facts do not lie. Top dogs Hull have scored <u>30</u> goals, while at this point we have just nine. Town fans, overjoyed at stealing three points, were also delighted by their pre-match welcome in the heaving Shrimpers Bar.

KIDDERMINSTER 1 SOUTHEND 2 (11/10/03): For those who missed it, like working me, allegedly one to say 'Wish I'd been there'. Joy abounded after 15 previous away dates without a win and, by all accounts, the victory was thoroughly deserved. Leon Cort had one header disallowed, but there was no stopping Mark Warren's free-kick thunderbolt or 'headache' victim Tes's six-yard volley right at the death from Leon Constantine's nod-down. An 84th-minute John Melligan strike – he likes scoring against us – gave us a nasty scare, only for the gods to smile on us for once. Oh, and England made it to Euro 2004.

SOUTHEND 2 BRISTOL R 1 (LDV Vans Trophy, 1st rd, 14/10/03): The need to earn a crust kept me away, though reports indicate this was a bright Blues show that brought a merited win despite us needing extra-time to achieve it. After falling behind 10 minutes from the break, Leon Constantine required only three minutes before stroking us level. Then Mark Gower dug out one of those pieces of brilliance we would love to see him conjure up more often to seal our passage with a 110th-minute 20-yarder curled sweetly into the net. Can we keep this up?

OUTHEND 1 LEYTON ORIENT 2 (18/10/03): Errrrr, no. What a birthday treat. First we get the 'dream' draw of Swansea away in the LDV Vans Trophy second round and then the faithful are dished up a performance that can best be described by any one of the following adjectives – appalling, inept, leaderless, shambolic, unacceptable, depressing. Easily the biggest cheer of the day came in a jam-packed Shrimpers Club pre-match when Will Greenwood burst over for England's try against South Africa in the rugby World Cup. Blues genuinely were as BAD as I can remember of late, against a side just dumped out of the aforementioned LDV mega-tournament 4-1 by mighty Dagenham and Redbridge. And it is no good pretending otherwise or attempting to come up with excuses. We had a 6,000 crowd, yet one more chance to impress the casually curious, and, yet again, blew it. I know Martin Ling used to play for us, but there was no need to add lustre to his Brisbane Road job application. Leon Constantine's 90th-minute strike raised hardly a whimper, let alone a cheer, following as it did hard on the heels of the laughable own-goal by poor old David McSweeney. That alone had hundreds hurling themselves towards the nearest exit. 'Offside' was the familiar cry for the O's opener. It looked close on the TV replays. Yet perhaps we should be asking instead why their scorer was left totally unmarked to nod the ball past a stranded Darryl? First half their keeper could have sat in front of the 1,500 Orient following in an armchair. He was totally untroubled by our feeble diet of hopeful long-ball punts and, apart from the efforts of Mark Gower, our dire lack of any width. 4-5-1 may be OK when you are trying to pick up a point away, but at home it smacks merely of fear. What made it worse was that for the second half we were playing only 10 men, after Lee Thorpe was sent off for elbowing Duncan Jupp. Jay Smith should have put away a close-range header and sub Michael Kightly at least tested Lee Harrison. But that was about the limit of our threat over 90 minutes of sheer torture. Before kick-off, operatic tenor Lawrence Robinson gave us a rousing rendition of 'Jerusalem'. He could have returned on the final whistle and hummed 'Siegfried's Funeral March'. Back to square one.

SOUTHEND 0 BOSTON 2 (21/10/03): I inquired of Mr G: "Are you coming to the Boston game?" His reply was a curt: "I am not paying another £15 to watch that s***e!" As ever, he proved what a shrewd analyst of the beautiful game he is. I thought this was a bit better than Orient thanks to the reversion to 4-4-2, but plenty of

others disagreed as we failed to score and watched three more points disappear down the Swanee on what was presumably another 'bad day at the office'. We may as well try 1-0-10 next. As expected, many voted with their feet after the Os misery and there were just 2,463 of us left on the night, including about 150 followers of a Boston side boasting the up-front 'potency' of a certain Graeme Jones. Fears for the worst set in soon after Drewe B had headed a cracking little 19th-minute cross from Mark Gower – again our one genuine performer – wide from all of four yards. By half-time bellows of 'Rubbish' and 'Absolute c**p' were echoing round the East Stand. The one bit of colour on a bitter night was provided by the Blue Belles in a selection of vivid skimples tighter than an England rugby jersey. Wiggers' half-time call to arms got the familiar response – precious little. He threw in Michael Kightly for 45 minutes, though, sadly, it was his misplaced pass which led to the visitors' opening goal. Fifteen minutes later an innocuous-looking lob forward totally caught out our defensive cover, a Boston boot was stuck out and the ball looped lingeringly over Darryl's flailing right paw into the corner of the net. Game over. Plus there was the added farce of us being reduced to 10 men when Jamie Fullarton 'did his groin' after we had just thrown on our third sub. Mr Coxell, shamelessly sickened that he had forgotten his 'student' card and so was unable to gain access for a mere £6, fondly remembered the time when those in the East Stand were allowed to greet such an unedifying 90 minutes with a barrage of cushions. Oh happy days. As we departed the yells had changed.....to 'Resign!' Keep smiling.

MACCLESFIELD 1 SOUTHEND 2 (25/10/03): We needed a big response – and, thankfully, got it. Aided by Macc being reduced to 10 men midway through the first half for a twin yellow card, Blues played the ball around neatly at times and took a 51st-minute lead as Leon Constantine made it seven for the season with a bobbly volley. Eight minutes later we got yet another penalty and, wonder of wonders, actually put it away. Jay Smith forgot his previous failures to end the nightmare run of four successive misses – plus four blown points – and see us safe. Even then we typically handed the home side a consolation strike right at the death as concentration lapsed. A manager did get the bullet – but it was Macc's David Moss! Our next concern looks like an injury crisis.

RESUMABLY Ron must have been among those voting at the recent get-together of Football League chairmen for a 10-point deduction for all clubs going into administration for 2004-05. Does our esteemed leader know something we don't?

Pity, because anything resembling his old potency is exactly what we need. But remember there has been a darker side to The Man – as this little encounter on one Radio Five Live phone-in pre-Japan and South Korea reminded us all.

CALLER: Hello, Stan. Sven should take you to the World Cup. STAN: Why? CALLER: Well, you're an expert on beating Swedes. STAN: Get him off!

I have confirmation that Candice from Benfleet – see NUMBER 50 – did indeed allow her 'front bottom' to be accidentally exposed on Sky's Soccer AM. And to think it was 10 hours BEFORE the watershed!

Don't you always enjoy listening to Alvin Martin pontificating about the game as a pundit on TalkSPORT or Sky? HERE were acrimonious exchanges over who was responsible for the breakdown in communications. Accusations of bad faith flew in both directions. One side said they had made their position crystal clear. The other insisted they had been misinformed. Both parties felt statements were necessary to try to put across to worried observers and vested interests who was right and who was wrong. Committee minutes were quoted, misunderstanding mooted. But blame for what had happened was carefully avoided by all those involved.

Right, enough on the breakdown in the latest phase of the Northern Ireland peace process. Though it is hard not to draw parallels with the whys and wherefores of the absence of Steve Wignall and John Stannard from putting in their much-trumpeted appearance at the SUSCT AGM held in the Shrimpers Bar on October 22.

We all knew a month ago that deputy chairman Geoffrey King could not attend. And it also transpired that Ron was not going to appear because of yet another potential 'holiday' commitment or some such. But we felt we had an understanding that there was no reason why Wiggers and United's Trust-sponsored head of groin strains should not attend on the night for a bit of a post-meeting Q & A session on our current 'parlous' position and what it is really like to get to grips with Kevin Maher's thighs. Sadly, this view was not deemed to have been handed down as gospel by our esteemed head honcho. Instead, it was taken as read by the Trust in the light of minuted discussion over the best part of six months at assorted liaison committee get-togethers. In the end, Ron seemed to feel it was crucial that any Q & A should feature his good self in attendance – even one simply on playing matters and purchasing physio equipment with Trust-provided funds. You get the feeling there was also a touch of cold feet at the prospect of Wiggers going into bat on a very sticky wicket with no 'hand-holder' present. He was hardly likely to be hailed as the Sven Goran Eriksson of the Third Division in the wake of four days of hell at the Hall culminating in the Boston debacle. I am positive he could ably have stood up for himself. But it was decided Messrs Wignall and Stannard should stay away – and needless damage was done to Trust-SUFC relations.

The Trust took a bit of pull-out stick from the usual suspects, who at the time had to be oblivious of all the facts. Yet the Trust committee believes everything possible was done to ensure the attendance of our guests and that, on this occasion, we could not have done more. Time now, surely, for all to put this matter to bed and move forward.

Derek Wilshire attended as a board 'observer' from United and helped swell the audience to 45 brave souls, who ignored the sad lure of Rangers v M******** U***** on the telly to do their duty as SUSCT members.

UR chairman Trevor Bashford kicked off the evening with his overview. He pinpointed the continuing gloomy outlook for almost all clubs outside the tawdry cash fest of the Premiership and the hope that the Franchise FC philosophy never rears its ugly head anywhere else. He noted Fossetts Farm has gone quiet for now, for obvious reasons, but highlighted what ambition can mean even to a club like Darlington with their new 25,000-seater ground. Filling it, of course, is another matter. As for Blues, we continue to 'flatter to deceive'.

And while Trust links with the club have probably never been 'closer' (prior to the AGM anyway), the key is supporter representation on the board asap. (Thirty clubs have it, we want it too. As the sixth Trust in existence, we are lagging behind and may press the issue at the next United AGM). There was a eulogy for the committee, who Trevor stressed are all *volunteers* often putting in hours of work for the Trust each week in their spare time. Trevor noted that last year the Trust was heavily involved in the Save Our Southend campaign, will continue to push for that board seat and will strive to push our membership over the 'magic' 1,000 mark. Our current membership on an average gate at present of 3,956 is already some achievement. We will keep liaising with other Trusts and the Football Supporters Federation and keep trying to widen our appeal. We will continue, too, to attempt to raise funds to strengthen our backing for SUFC and the community.

Treasurer Craig Fillary's accounts revealed an excellent surplus of income over expenditure for the year to June 30 of £10,215 – up from £1,729. The only significant fall in casual income came on donations. Fund-raising income soared by nearly £7,000, the vast bulk of which was due to the efforts of Alan Perry, whose hunger for finding schemes that will benefit the Trust's coffers knows no bounds. Membership revenue was up by £1,400. Costs to the Trust, though, have increased, especially on the packing, postage and insurance fronts. £2,000 was handed to United in sponsorship and £1,500 in physic equipment. Travel lost only £205, down around £2,000 on 2001-02, in the loving hands of Chris Berry. Overall, solid progress. The accounts were approved unanimously.

Membership secretary Paul Yeomanson reported that since the last AGM our number had risen by 148 to a bestever 929 adults and juniors (806/123). Without the 100 lapses, we would already be over the 1,000 mark. He requested renewals always be carried out as swiftly as possible. From January 1, 2004 a scheme will be put in place offering a 'gift' to anyone who signs up 10 or more members to the Trust. Next came the potentially thorny issue of the membership fee. This has stood at £5 since the inception of the old SUISC under Tony Hall back in 1998. But the committee had agreed that to meet the additional costs threat, this should rise to £7 for adults, UNLESS they sign up for two years or more or agree to pay by standing order when the charge will remain at £5. The fee for Under-16s would remain at £5. After a short debate and the consideration of a couple of interesting alternatives, the new fee plan was approved unanimously by the meeting, again to start from January 1. <u>Now it needs our full</u> <u>membership's approval and you will find a small form at the foot of the newsletter which you can return to Terry</u> <u>Jeffreys by November 15. Or vote by e-mail.</u>

HE election of Trust officers followed. Those elected were.- <u>President</u>: Sir Teddy Taylor MP. <u>Chairman</u>: Trevor Bashford. <u>Vice-chairman</u>: Paul FitzGerald. <u>Secretary</u>: Terry Jeffreys. <u>Treasurer</u>: Craig Fillary. <u>Membership Secretary</u>: Paul Yeomanson. <u>PR/Club liaison Officer</u>: Dave Scriven. <u>Fund-raising Officer</u>: Alan Perry. <u>Committee</u>: Chris Berry, Brian Cotgrove, Richard Coxell, new boy Robert Craven, Joe Elliott, John Everett, Kevin Feasey, Jon-Paul FitzGerald, Kathy Jeffreys, Nigel Rickard.

The one major issue discussed under 'Any Other Business' concerned the Trust's 'contingency plan' should Delancey exit and Martin Dawn plc decide SUFC is no longer a viable entity. Paul FitzGerald, who relishes keeping our overlords on their toes, replied that what is important to Delancey is that eventually they see a return on their investment. The longer we go with no Fossetts Farm or similar such plan, the more likely it is their shareholders will ask 'Why have we got this non-performing asset called Southend United?' Should they say enough is enough, then the focus will be on Ron to find an alternative way out. While the Trust has a small cash asset, it would be nowhere near enough to run the football club. Should that ever be necessary, then outside funds would have to be sought. But Paul had to admit: "There is no Plan B. Without Fossetts Farm we are in trouble." Jerry Moss asked about a possible ground share, to which Trevor replied that the Ron plan is to keep in the borough of Southend. "There would be lots of costs involved in a share and we have heard of no such plans."

Then Derek Wilshire bravely stuck his head over the parapet to announce: "There is no question of the board seeking to move outside the area. Relegation has also not been discussed. We hope that in a few weeks' time that prospect will have disappeared. Ron is already looking for another suitor and doing his damnedest to find one." The murmur this brought was palpable. Paul FitzGerald acknowledged: "Ron is a fighter and wants to stay."

At the moment, we must just keep our fingers crossed. As Kevin Feasey stated 'All we can do at present is to watch what clubs like Oldham and Chesterfield get up to, maintain our membership and keep finance coming in." (Oldham's Trust has raised £200,000 to help keep the Latics alive and is seeking a board place for their efforts).
