## BBC ESSEX - Out of Tune with the Fans !!!! - by Paul Napper

BBC Essex recently made an editorial judgement to forego their usual full live coverage of away games for both Southend United and Colchester United. Naturally, this has led to a lot of supporters feeling rightly aggrieved. BBC Essex has in the past consistently delivered quality full live coverage of whatever Essex league team was playing away that Saturday. This was beneficial for a number of reasons - but mainly it allowed fans who for some reason weren't able to go to the match to follow the fortunes of their team.



In their wisdom, BBC Essex has decided to change a winning formula. The decision was made at the very top - by the editor of BBC Essex, and his reasoning was nothing more than to broaden the coverage, so they don't miss anything else happening in Essex sport. This in my opinion, and in many other peoples' opinions, is wrong on two counts. Firstly, if people wanted a magazine-type show they can watch Sky Sports News. Secondly, as the majority of the people listening in on a Saturday afternoon will be fans of either Southend or Colchester, they won't be interested in how Canvey are doing, certainly not to the extent of live coverage.

We are told that this isn't due to cost (although some sources say otherwise), and indeed BBC Essex still send reporters to every game anyway, to report for Blues World. We are told that they are still providing commentary, but not as they used to. There is still a board at Roots Hall promoting their coverage of the Shrimpers - is this false advertising?

In any case, we the fans believe this is wrong - why change a winning formula and why deprive hundreds of fans of listening to full live coverage for an editorial decision based on nothing but gut-feeling? Many other BBC stations provide full live commentary and have no problems - why should we be different?

So, what can we do? Well, there is an online petition which can be found here -<u>http://www.petitiononline.com/bbcessex/petition.html</u>. The petition now has over 800 signatures - please sign your name. We have also handed out a paper petition at Roots Hall, where over 400 people signed to show their feelings. I have emailed the BBC Trust responsible for complaints and they have logged the complaint. I have also enlisted the support of James Duddridge MP, who is doing his bit - can you contact your MP for support?

Many fans have emailed the editor of BBC Essex, and a representative of the Trust will be meeting him - he wants us to give him a few weeks to see what we think of the new show. Well, we have, and it's insufficient. We want the old show back, and we want it back now.

### **Liason Meetings**

As most members are aware, the Trust Committee members participate in monthly meetings, in which various supporter concerns and matters are discussed, with club management, including the Deputy Chairman, other Directors and Head of Commercial. The Trust enjoys a healthy working relationship with the club and all supporter comments are taken on board by club officials.

The minutes of the meetings are published on the Trust website but points which may be of interest are repeated below.

### July

An update was given on the progress of the new Stadium Development at Fossetts Farm including funding which is now being discussed with various parties, with further news expected in around 3 months.

It was also confirmed that the deal with Sainsbury's meant the club were obliged to leave Roots Hall in 2010.

The clubs current financial position was outlined confirming that the summer was a difficult time normally and specifically that the expected "war chest" for new players would not be forthcoming until funding was in place for the Fossetts Farm development.

The Trust's Donation to the Youth Team for the 2008/09 Season was discussed and it was confirmed that Ricky Duncan would like some Trust Committee Members at the planned team photo shoot on August 5<sup>th</sup>.

It was also agreed that the Trust's Junior Members Training Day should be run in the October Half term and that a date should be agreed with Ricky Duncan.

The cessation of full away commentary by BBC Essex was discussed and it was confirmed that Southend United had not tried to increase the cost for this season. It was stated that the BBC were alluding to the fact that they were, and that the Trust are still trying to contact the individual responsible.

All present expressed their disappointment with BBC Essex's actions.

## **MATCH REPORTS**

### Saturday 9th August 2008 - Peterborough (Home) - Result 1-0

A new season starts, with a new squad but the confusion continues. Will Nicky Bailey start? Is Nicky Bailey suspended by the club? Will he refuse to play so as not to get injured in case of a move to Charlton or is it Crystal Palace? Do Southend United need to borrow £80m or is £45m or is a different figure – the quality of reporting in the Evening Echo hits its usual highs? Where do they get their information?

Day 1 of season 2008 / 2009 was a drab, wet and cold day and the football was not a lot better. I always thought that the first few games of the season are played in a heat wave; players need to take on lots of water and the East Bank struggle to see the game due to the bright sun. Saturday was definitely an exception to the rule!!!!!! Still only 22 home games and 23 away Coca Cola league games to go and we have three points in the bag. Perhaps 16-1 is not a bad bet after all.





As this was a new squad who would the fans pick on (i.e. no Mark Gower) but the pre match antics of "Player of the Year" Nicky Bailey saved the day. Good starts by all the new boys Mildenhall in goal, Harding at left back and Paul Furlong up front. Betsy also looked lively when on as substitute for Scannell, who himself looked the most likely to score.

The only goal and perhaps on shot on target from either side (i.e. I cannot remember Mildenhall or Lewis in the Peterborough saving a shoot in anger, albeit both dealt well with long range shots and crosses. In the 76<sup>th</sup> minute Peter Clarke won the day for Southend with a close range shot from a corner. Three Peterborough players yellow carded but little else to write home about. Still I have always said happy to win 1-0 in a scrappy game than lose playing "beautiful football". Three substitutes introduced in last 15 minutes.

### Saturday 16<sup>th</sup> August 2008 - Millwall (Away) – Result 1-1

What a fantastic weekend for sport with Essex winning the Friends Provident Trophy at Lords; New Zealand beat South Africa in the tri nations rugby; and Great Britain win 17 medals, including 8 gold medals in 48 hours but our beloved Southend United lose 2 points deep into "time added on" after a dogged battling performance with a much change side and bid emphasis on youth. Pretty the game might not have been but a battling performance against a poor Millwall side it definitely was. I can understand why Steve Tilson and his players were gutted because the equaliser was totally undeserved and for Millwall an "unexpected get out of jail card".

A much changed Southend team with no Bailey (run away to earn more money and a longer contract at Charlton). Scannell and Walker (added to the injury list) and Furlong (rested on substitute's bench) battled well and took the lead after six minutes when the Millwall goalkeeper David Forde (convinced he is a relative of the Ford family who travel on the Shrimpers Trust coaches to all away games albeit a different spelling) dropped the ball on the edge of his six yard area and Revell was on hand to gratefully accept the goal scoring opportunity – let us hope he can do the same against his former club on Friday. A dire refereeing performance from Keith Stroud who booked eight players (four per side), let a number of incidents go but ensured there was no flow to the game with petty free kicks and continually measuring out ten yards. I think the five minutes added time was about right but not good in respect of the result. Late into added time a shots hits the bar, is saved by Mildenhall and out of nowhere Ahmet Brkovic equalises. Underserved yes but we would all have accepted 4 points from the first two fixtures when the fixture list was issued.

### Friday 22<sup>nd</sup> August 2008 – Brighton & Hove Albion (Home) – Result 0-2

Friday night returned to Roots Hall but the crowd of 7,976 was disappointing for a local derby between two sides undefeated in the league. Appreciate a Bank Holiday weekend and the economy entering a recession but I would have expected a bigger crowd. Still those who attended saw a vastly improved Southend United performance and playing their best football of the season to date only to be robbed by another poor refereeing performance which had a major impact on the result.

The only change to the starting eleven from the Millwall fixture was the return, on loan of Hal Robson-Kanu. He played on the left hand side of midfield and had an influential game, albeit could not inspire a goal. Charles Ademeno returned to the bench where we also saw the introduction of another loan signing, Lee Sawyer from Chelsea

A bright start from Southend with Alex Revell hitting the post and several good crosses from both wings. We then saw the first of many bad decisions from our referee Jamail Singh. Revell clattered Michel Kuipers in the Brighton goal. Punches were thrown and Kuipers went on to be "man of the match" making many fine saves. Two yellow cards were issued when red more appropriate. Mr Singh went on to issue a total of six yellow cards, including Peter Clarke for winning the ball, and one red. For the remainder of the first half both sides played good football but the half time was 0-0.

In the 63<sup>rd</sup> minute of the game, which had seen a bright start to the second half with both sides going close, Franck Moussa and Alex Virgo, two committed mid field payers, contested the ball and Franck won. To the amazement of both sets of fans and both benches Mr Singh blew for a free kick to Brighton and brandished a red card to young Mr Moussa. To quote Mickey Adams, the Brighton manager "I can understand Tilly's disappointment because it looked like a genuine case of both lads going fairly for the ball".

This was the turning point of the game. Sawyer replaced Revell in the 70<sup>th</sup> minute and his first involvement was to tackle the experienced Nicky Forster who went down as if pole-axed albeit no contact made. Sawyer was cautioned and from Livermore's free-kick Murray lashed the ball home to make it 1-0 Brighton. For the rest of the game there was much barracking of Mr Forster by the West Bank who allegedly retaliated by gesticulating at the home fans. Even if caught on camera assume no action will be taken because he was provoked!!!!!!! Still an excuse for the orange coats to push and shove the home fans. Southend continued to press, a Barnard shot was cleared off the line and Kuipers performed heroics in the Brighton goal. In the dying seconds Forster tapped in the far post to make the final score Brighton 2 – Southend nil.

How is the respect campaign to work when you have referees like Messrs Attwell and Singh brandishing red and yellow cards like confetti? When will match officials go back to using common sense and forget about the assessor in the stand? At this rate we will have no players due to injuries and suspensions!!!!!!
