TRUST HERITAGE EVENTS – by Richard Coxell

The Trust have done a number of "heritage" events. We have erected 2 plaques and renovated Oliver Trigg's headstone in Sutton Road cemetery. As the 2 plaques were getting a bit tired they have been repainted, so it's an opportunity to remind fans of what we have done. All are reminders of the fact there has only been one professional club in the Borough and reflect its history and importance.

The Blue Boar



In the 1990s the Blue Boar was under threat of demolition. Fewer people were going to pubs and fewer seemed to be going to the Blue Boar. It was abandoned and derelict. There was a hole in the roof and the pigeons had got in and nested and were making a disgusting mess. A developer had bought it to develop it in to flats but was having difficulty in getting the plans passed. There was an article in a local paper suggesting the Hotel should be knocked down. No one but hardened Blues fans seemed to know about its history and the fact that Southend United was founded there by a group of businessmen headed by the then landlord, Oliver Trigg in 1906. Oliver Trigg's family were in the pub business. His father was a publican and so were his brothers. He was a freemason like so many other businessmen at the

turn of the last century in Southend. In fact Oliver Trigg was in the same Lodge as Frederick Ramuz who bought farmland where many Leigh houses now stand and also the Grand Hotel. The town was booming. Oliver Trigg was soon knocking down an historic house next door called Reynolds to build an extension with a billiard hall. The massive fireplace is in the Central Museum. Nothing was going to stand in his way of bettering himself.

Trigg and his friends thought Southend needed a professional club to put the town on the map. So he did it. He recruited Bob Jack to be the club's first manager and put in money which he never got back. The rest as they say is history.

When the pub was renovated admittedly on a much smaller scale than before with flats attached the Trust put up a plaque to remind everyone of the Blue Boar's importance to the club and town.

David Jack

Bob Jack was born in Alloa but played most of his football in England, joining Bolton Wanderers in 1895 as a 17 year old. He moved to Preston but ended his playing career at Plymouth. Before coming to Southend he had been player manager there for a year. He joined Southend as its first manger in 1906. It was an inspired choice. Bob Jack brought his wife and 3 children to Southend. Rollo and Donald would become professionals but his other son David would become something rather special. They were enrolled in the local school on the junction of Hamlet Court Road where they lived and Leigh Road as the now London Road was then called. Leigh Road ran from the Cricketers (you can see the original



Leigh Road sign on the building) to where the current Leigh Road is. The school was one of the original Board schools and called Leigh Road School. Years later its name was changed to Hamlet Court. It is now demolished and is the car park at the top of Hamlet Court Road. However if you look at the wall you can still see targets painted for the school kids to throw balls at.

Bob Jack brought a few close friends from his playing days down to Southend. One was a fellow Scot called Jocky Wright, but more of him later. Bob Jack's stint in charge was a success and he cemented Blues' position as a fledgling club harnessing some of the players who had played for the local amateur team Southend Athletic like Alfred "gonger" Frost with a few local signings like Harold Halse from Wanstead and Jimmy Axcell from Leigh. He sold Halse to Man United for £350 and threw in Axcell for another £350 the maximum transfer fee at the time. In his first two seasons with Southend they won the Southern League Second Division title, gaining election to the Southern League First Division in 1908. Bob Jack was still playing himself but retired at the end of the 1909–10. Unfortunately Bob Jack had fallen in love with Plymouth and was offered the chance to go back down there and re-joined Plymouth Argyle as manager, remaining in charge at Home Park until April 1938 when he retired.

During his 28 seasons in charge, Jack had guided Argyle to the Southern League title in 1913 and into the Football League in 1920. In their first season in the league they finished 11th in the Third Division but finished runners-up in all of the next six seasons. However only the champions were promoted in those days. They finally clinched the title and promotion in the 1929-30 season. He is often considered Plymouth's most successful manager.

But what of his son, the man with the wonderful name of David Bone Nightingale Jack. Former family surnames were often used as middle names by Scottish families.

An inside forward he started his career with his father's club, Plymouth Argyle in 1919. There he scored 15 goals in 48 appearances in all competitions. In 1920 he returned to the town of his birth, moving to Bolton Wanders for £3,500. He spent eight seasons with them, forming a formidable partnership with Joe Smith and between them they scored over 300 goals. While at Bolton, he made history by being the first person to score a goal at Wembley in the 1923 cup final which Bolton won 2-0 against West Ham.

A year later, he won his first England cap. In eight years he played eight times for his country and scored three times. He captained the country as well. He continued to have success with Bolton, winning the FA Cup again in 1925-6, scoring the only goal in a 1–0 win over Manchester City. He was the club's top scorer for five of the eight seasons he was there, scoring 144 goals in 295 league matches.

In 1928, with Bolton in financial trouble, he was signed by Herbert Chapman for Arsenal for $\pm 10,890$ (nearly double the previous world transfer record). The story goes that Chapman negotiated the transfer with Bolton's representatives in a hotel bar, his tactic being to drink gin and tonics without any gin in them, while letting the other side drink as much as they possibly could. Chapman remained sober while the Bolton representatives got very drunk, and managed to haggle down the fee to a price he considered a bargain.

David Jack's career with Arsenal was very successful. He became a regular straight away. He was the club's top scorer for the 1928-9 season. Although less prolific than centre-forward Jack Lambert, he still scored important goals, including the one in the 1929-30 FA Cup semi-final against Hull City which sent Arsenal through to the final; Arsenal beat Huddersfield Town 2–0 in the final and Jack became the first player to win the Cup at Wembley with two different clubs.

Jack continued to feature for Arsenal through the early 1930s, recording a personal best of 34 goals in Arsenal's First Division winning season of 1930-31. He won two more titles in 1932-33 and 1933-34. At the end of his playing career he went out on a high and retired soon after winning his third

league medal, in May 1934. In all he scored 124 times in 208 matches for Arsenal, making him the ninth-best goalscorer in the club's history.

Management loomed. So where would an ex Southend schoolboy start his managerial career. The poisoned chalice awaited. David joined Southend United as manager for £750 a year, the highest salary in the Third Division. His fond memories of his time as a schoolboy probably swung it. My father saw his first ever match as manager at a Wednesday afternoon reserve game in 1934 when he was 8 years old. Unfortunately David Jack could not play for Blues due to League rules at the time. He moved to live in Westcliff in Mount Avenue and The Drive. What could possibly go wrong? A new manager, one of England's finest ever players at that time and a new ground at the Stadium. His achievements as manager were modest. His best position in the league was 10th. Bob Jack came down to help his son with some scouting and advice and lived in Leigh. He died in Southend in 1943 and his ashes were scattered on Home Park. The war intervened and David Jack worked in the city for Barclays Bank. After the war he managed Middlesbrough, then ran a London pub and then managed Shelbourne in Ireland. He then did a bit of part time scouting for Blues. He died in 1958 at the age of 59.

Anyway back to Jocky Wright. Jocky had stayed in Southend after his friend Bob Jack moved to Plymouth and eventually became a coach painter with the Southend Corporation buses. He missed out on an England cap when at Sheffield Wednesday when the England bosses found out he was Scottish. A bit of a giveaway being nicknamed "Jocky". He lived in Root Hall Avenue with his family and his son Dougie was a very good footballer and played for Blues in 1937. However he was way too good for us. David Jack had signed the Scot Jimmy Nelson in 1935. Jimmy had captained Newcastle in their 1931-2 FA cup final victory over Arsenal and when he retired in became mine host at the Golden Lion in Prittlewell for a few years. So one night Jimmy, Bob Jack and David met with Jocky to discuss Dougie's future. They decided Newcastle was the team he should join. Jimmy had the connections and the deal was done and in May 1938 Dougie was sold to Newcastle for £3,250. He was said by many to be the best wing-half in the country at the time. He was capped for England just before war broke out. However he injured his leg in the war and was never going to be able to play top flight football again and went to Lincoln for £600 in 1948. Len Shackleton said he "had been twice as good as Bobby Moore". He ended up with Blyth Spartans and married a local girl and died in a Bedlington nursing home in 1992.

So when you pass the now newly refurbished Golden Lion spare a thought to that night, and as you pass the plaque think of those early years of Bob and David Jack.

Oliver Trigg's Grave



Oliver Trigg is buried in Sutton Road cemetery. Some years ago the headstone was knocked over by a car whose driver was visiting one of the chapels (the grave is near the chapel on the left as you look through the gates). The Trust along with the club reinstalled and cleaned the gravestone. Unfortunately the doves head had been knocked off in the crash and would have been too expensive to repair.

If there was any doubt about Oliver Trigg's importance to the club a copy of his obituary in the Southend Standard speaks for itself.

Southend Standard February 27th 1919

DEATH OF MR OLIVER TRIGG

FOUNDER OF SOUTHEND UNITED

We regret to record the death, which took place on Tuesday morning of Mr Oliver Trigg, licensee of the Ivy House Hotel (NB now Chinnery's) Marine Parade, Southend. The news of his sudden demise will come as a painful shock to his many friends, for he was about as usual last week and only on the previous Monday went down to Lincolnshire for a few days holiday. While there he contracted a chill and he returned to Southend on Thursday and at once took to his bed. Complications occurred and he passed away at 1 a.m. on Tuesday from heart failure. The late Mr Trigg had been in indifferent health since October 1917 when he had a serious illness but he had recovered from that indisposition and latterly had seemed much better. It is a sad coincidence that he always had a dread of the month of February and a presentiment that he would die during that month; his father and two brothers having died at that period.



The fourth son of the late Mr William Trigg of the Ship Hotel Southend, the deceased, was in his forty second year. After assisting his father in his business for several years he held the licence of the Foresters Arms. He then took over the licence of the Blue Boar Hotel and while there carried out extensive alterations to the premises including the addition of a billiard room. It was during the time that he was licensee of the Blue Boar Hotel that the suggestion was first made for the formation of the Southend United Football Club. Mr Trigg may be regarded as the founder of the club though he was assisted by in the venture by many local sportsmen. It was at a meeting held on May 19th 1906 at the Blue Boar Hotel that the bold step of professionalism was decided upon. The hard work of Mr Oliver Trigg proved successful in obtaining the clubs admission the Southern and South Eastern League but despite an extensive canvass of the town and a public meeting the response for subscriptions for the share list was but meagre and Mr Trigg had a very substantial deficit to face before the Company went to allotment. On the first years working he advanced £861 to the club as a loan which was never repaid. From its foundation in 1906 until Southend United ceased operations in May 1915 Mr Oliver Trigg remained a director of the club and he was chairman of the directors during the troublous and harassing period in the first year of the war. Here again he rendered the club much financial and other assistance and no one was more pleased than he that as a result of his year in office the club escaped relegation. He was always a frequent attender at the matches, at home and away. Mr Trigg was also a warm supporter of Southend Amateurs Football Club and was for several years their president. With Mr Geo. Hogsflesh he took a prominent part in the formation of Southend Harriers and was until the time of his death a liberal supporter of their funds and competitions. The deceased gentleman was also fond of horses and driving, while he was an excellent shot with a gun. About 12 years ago he took the licence of the Ivy House Hotel where he has remained ever since and in order to promote boxing, he had a boxing hall erected at the rear of his premises. He was also very fond of billiards, professional and amateur and a good amateur cueist. Of a cheery and genial temperament, he was popular with all who knew him and he made many friends among directors and officials of other clubs who will hear with much regret of his early demise. He was a whole hearted modest sportsman, always ready to help deserving form of sport. He was also a gentleman who would scorn a mean action. For many years he had been a Freemason and a member of the Privy Lodge. He also formed a Buffalo Lodge at his hostelry. Two of his brothers Mr Sydney Trigg and Mr Ambrose Trigg predeceased him, both at an early age, while his elder brother Mr Oswald Trigg of the Ship Hotel has recently undergone a severe operation at Guy's hospital and is not yet convalescent. He leaves a widow to mourn his loss. The funeral will take place on Saturday at 2 o'clock from Marine Parade and 2.30 at Sutton Road cemetery.

What a guy.

Quid-a-Goal

Our Quid a Goal scheme is now up and running for the 2014/15 Season.



So far we have raised \pounds 879.25. As our push for promotion continues we hope to see more money raised in 2015

The aim of the scheme - like most of the Shrimpers Trust's activities is to raise money for Southend United Football Club and make sure that there is a club for us to be supporting in the foreseeable future.

In particular, some of the money raised from this Seasons "Quid a Goal" scheme will again be donated to the Southend United Physio Ben Clarkson and his Department to help purchase much needed equipment.

This is how it works:

Those who support the scheme with a pledge have their name and details of their pledge displayed in the United match program each week and are detailed on this web site.

We ask you to pledge ± 0.25 , ± 0.50 , ± 1.00 or more under various headings such as clean sheets, various players scoring goals, or team goals. This does not have to cost you a fortune as you can easily judge in advance how much your pledge will cost you come the end of the season.

For example, the Blues rarely manage more than 80 goals in a season from 1st team matches. A £0.25 per goal pledge would therefore most likely not cost you more than £20.00 come the end of the season. If funds are tight how about £1 for every goal scored by our full backs? If you chose to do £0.50 per point and we finished up with 72 points as we did last season this would cost you £36.00. At the end of the season we will write to you thanking you for your support of this initiative and asking you to send us a cheque for the amount owed.

Last year this scheme raised around \pounds 1,850 from the 68 people that helped us. This includes support by some of the Southend United's directors.

If you would like to help raise funds for this worthy cause you can do so by completing the QAG Entry Form which has been included with this newsletter and return to us either by post to the address shown on the form or by handing in at the Trust Info Stand in the Shrimpers Bar prior to any home game.
