I support Southend United Football Club's new stadium development, which includes a 21,000-seater stadium, cinema, Hilton hotel, restaurants, state of the art Academy & indoor soccer domes and enabling residential and retail development. I support the development for a number of reasons including:

• Roots Hall stadium opened in 1955 and whilst can create a good environment on match days is no longer fit for the modern game. The stadium lacks facilities, is tired and now restricting the Club's growth.

• A new stadium and training facilities will be the springboard required to get us up and keep us in the Championship and possibly beyond.

• New facilities will attract higher profile players and the enhanced Academy will help our successful youth set up to flourish still further... the life blood of our Club's future.

• The new development will put us on the football map, generating revenue across the region. In the Championship we would currently see the likes of Leeds United, Aston Villa and Derby County and several thousand travelling fans spending money in our town.

AGM - RON MARTIN Q&A REPORT

The 2018 Annual General Meeting of the Southend United Supporters Society Limited was be held in the Shrimpers Bar, Roots Hall Stadium on Monday 19th November 2018.

This was followed by a Q&A Session with SUFC Chairman Ron Martin.

Ron was in good spirits and addressed those present with confidence that the stadium project was progressing well.

The discussions flitted from subject to subject during the evening with Paul FitzGerald starting off by reminding Ron of his pledge to have Trust representation on the board several years ago and certainly during the period leading up to the building and planning for the stadium. Ron suggested that now was not the right time and although not a Trust representative, he considered Club Director Gary Lockett to be a 'supporter'. Ron went on to say that his primary objective was to get the Club on an even keel within the new stadium and after that he was happy to review requirements.



Ron was also informed that the Trust this season will surpass the \pounds 200,000 level of donations to Southend United and related causes.

The discussion moved on to the lack of a Chief Executive at the club and Ron expressed the opinion that he had been unable to find the right candidate so had decided to carry out the duties himself. However in order to help grow the Club this was a position that would be required when we moved into the new stadium.

Ron said that many, including him, hold fond memories of Roots Hall. However he expressed concern that Roots Hall was no longer fit for purpose, highlighting the fact the East stand has wooden floors which in the light of the Grenfell disaster was a worry. Having said that, as reassurance a full fire safety certificate was in place.

Ron bemoaned the lack of space to add areas that can be used on non-match days and thereby add further income streams. He also explained that the new stadium works must start by June 2019 with the 2nd stage in November and the total build period will be 2.5 years. He advised there are 3 architects involved in the plan and 3 project managers for the stadium, the retail & the residential aspects. The retail tenancy lettings are 42% pre let but 55% triggers extra funding. The tenants for the hotel have been agreed. He felt people may not realise what a massive project this is, with traffic planning meaning roads and pavements for a large radius from the site have to be upgraded, including Warner's Bridge and several existing Roundabouts in the town. This even means pavements have to be widened in some areas.

He was asked if the new site will be a concrete jungle and replied that it certainly will not. As some evidence, he has already purchased 120 9m high trees which in view of the delays to the project are now 11m high and will cause greater transport problems now for the vendor! He advised that he plans a series of flythrough CGIs to help show supporters what the vision is. He was asked what can go wrong now, as he had expressed great confidence it will proceed. He advised that after

council approval which he was confident would be given, a Judicial Review could cause hold ups or if the Government 'called in' the plans again. However there are numerous parties involved in getting the project proceeding and he remains confident of success.

Ron felt that on an ongoing basis it will be likely he will need a partner for the project. He was keen to ensure there was no overspend as the Amex stadium have gone massively over budget and had cost \pounds 92M.

He advised that he will shortly be writing off £8M of debt the football club owes to him and intends to write of the other £9M in the foreseeable future, with the intention of leaving Southend United debt free. A discussion followed about 'Enabling Development' and how much money is required in income terms to make the project viable. It was pointed out that the Stadium Development income is separate from Southend United's Income and that at some point detail needs to be forthcoming on how Southend United will be funded.



There are 640,000 people living in the immediate locality and there is every possibility attendance could increase with a successful football team in Southend.

In answer to a specific question about access, Ron said The Park & Ride idea was not a sensible option in view of the lack of sites for the 'Park' aspect.

Several aspects of the footballing side were discussed and he made it clear that whilst there have been times he has gone into the dressing room, it is a rarity. Decisions regarding which players are employed, sold, released etc. are all down to the manager to control within his given budget. He feels Chris Powell is an excellent manager and possibly the best he has employed during his reign at the club likening his open and honest leadership style to that of Steve Tilson. He felt Chris has been hit by an incredible run of bad luck regards injuries.

Many players were discussed during the evening, including Nile Ranger, Michael Timlin's departure which many fans felt was a mistake, and Rob Kiernan's failure to overcome injuries. Ron was questioned regarding employing players who were injured at the time of being employed or who had a history of injuries. He advised that they have a network of scouts and a lot of information exchanges went on between clubs. He would like to keep Dru Yearwood as long as possible although accepted that in his long term interest he will undoubtedly move on. He felt Elvis Bwomono & Charlie Kelman are both great prospects. The decision to bring in Stockdale was not his but he felt putting Nathan Bishop in the team for an extended period at that time was a gamble that may not have been in Nathans long term benefit. Missing out on Lyle Taylor was understandable as Charlton represented a better prospect to Lyle.

He was asked what targets we had lined up for January. He reminded the audience that frequently mid-year teams get rid of players on loan etc. who are unable to make the first team and there are not many 'Taylor Moore's' out there. He is aged 22 and Ron hopes to keep him beyond January.

Discussions spread to Bilel Moshni, Adam Barrett's departure, Anton Ferdinand & Michael Turner's red card. Ron stated that he is not very good company after a loss by the team, as his wife and family will testify. He is deeply committed to its advancement and remains upbeat.

Ron was thanked for giving up his time and for his enlightening comments.

EFL FANS FORUM – CHECKATRADE TROPHY

On the evening of 10th December Clare and Shane Chapman went to an EFL fans forum concerning the Checkatrade Trophy at Wembley Stadium on behalf of the Trust.

The evening was hosted by David Prutton and in the first half of the evening Shaun Harvey (EFL Chief Executive), Colin Murray (presenter of EFL on Quest TV) and Ian Holloway (pundit on the aforementioned show) were there to answer questions. There were representatives from a large number of League One and Two clubs present.

It was emphasised that since the format of the cup was changed in 2016, (whereby premier league under 21 teams joined what had always previously been a cup for the lower league teams) the prize money has increased, as every team gets a participation fee and then prize money increases the further a team progresses in the competition. Lincoln City, who won last year, have been able to build a training ground which they wouldn't have been able to do without their winners' prize money. It was also mentioned how lower league players get the chance to play against youngsters who may become stars of



the future. Peter Crouch and Gareth Barry have also played for the under 21s (the under 21 teams are allowed a few older more experienced players, a fact that the fans at the forum thought rather ridiculous) and playing against players like these is supposed to give lower league players some great memories.

The league guests were asked for a show of hands as to who had attended a match involving the under 21s and only one person put their hand up. It was acknowledged that gates have dropped significantly since the format of the cup has changed but it was suggested that as the clubs get a participation fee, they are not losing out financially.

Colin Murray of Quest TV said he was in complete sympathy with how fans felt and Ian Holloway said he had first been against the new format but had now come round to it.

It was emphasised over and over again in the first half of the evening and even more so in the second when the panel changed to be Stewart Donald (owner of Sunderland Football Club), Joe Edwards (Chelsea Development Squad Manager) and Andy Amber (FA Director of Game Relations), the benefits for the youngsters of the under 21 teams from joining the competition. The Premier League squads are so large that the under 21s only played against each other before 2016. Now they get to enjoy lower league football and show themselves to the managers of those clubs, who can get an idea if they would like those players on loan.

It was agreed at the end of the evening that there will always be fans who are not happy with the format of the cup now. Shane and Clare thought the evening was geared to convincing us the decision however it felt like it was a PR exercise to justify the FA to bring on the 21s teams in the cup so weren't happy but it was a good evening with hot and cold drinks and food and lovely to see Wembley.

Quid-a-Goal

Our Quid a Goal scheme is now up and running for the 2018/19 Season.



The current total after 36 games is £1,635.00

The aim of the scheme - like most of the Shrimpers Trust's activities is to raise money for Southend United Football Club and make sure that there is a club for us to be supporting in the foreseeable future.

For the season 2018/19, some of the money raised from this 'Quid a Goal' scheme will be donated to Ricky Duncan's Youth department to help ensure that players of the quality of Daniel Bentley, Ted Smith, Jack Payne, Dru Yearwood, Elvis Bowomo and Charlie Kelman continue to be nurtured and made available to the first team.

This is how it works:

Those who support the scheme with a pledge have their name displayed in the United match program each week and are detailed on this web site.

We ask you to pledge ± 0.25 , ± 0.50 , ± 1.00 or more under various headings such as clean sheets, various players scoring goals, or team goals. This does not have to cost you a fortune as you can easily judge in advance how much your pledge will cost you come the end of the season.

For example, the Blues rarely manage more than 70 goals in a season from 1st team matches (15/16 League goals - 58). A £0.25 per goal pledge would therefore most likely not cost you more than £20.00 come the end of the season. If you chose to do £0.50 per point and we finished up with 80 points, at the end of the season we will write to you thanking you for your support of this initiative asking you to send us a cheque for the amount of £40.00.

Last year this scheme raised just over \pounds 2,000 from the 60+ people that helped us. This includes support by some of the Southend United's directors.
