TRUST STATEMENT – 24th September 2012

In light of recent issues surrounding the financial situation at Southend United FC, the Shrimpers Trust would like to make the following statement:

The Trust regularly meets with directors of Southend United through monthly liaison meetings. The most recent of these took place last week, with Club Chief Executive Gary Lockett and Trust Chairman Paul FitzGerald and Vice-Chairman Paul Yeomanson all present.

At the meeting various aspects of the Club's finances were discussed, with Gary happy to confirm that some elements were true, whilst others were merely rumour.

As is normal, the minutes of Liaison Meetings have to be signed off by both parties before being published, and can be found on the Shrimpers Trust website, www.shrimperstrust.co.uk, once this has occurred.

However, further to the Liaison Meeting we can confirm that The Shrimpers Trust have requested a meeting with Club Chairman Ron Martin, and that The Trust have suggested to the Club that we may be able to help, but that this would be subject to the approval of the Trust membership, who would be balloted accordingly.

The Trust do appreciate that it can be frustrating for supporters when there is a lack of information disclosed about serious issues regarding Southend United. However, fans can be assured that the Trust Committee, and particularly the Executive Board, is working hard behind the scenes to ensure that supporter opinion is represented.

Quid-a-Goal

Our Quid A Goal scheme is now up and running for the 2012/13 Season.

The total raised so far after 11 Games is £213.50

The aim of the scheme - like most of the Shrimpers Trust's activities is to raise money for Southend United Football Club and make sure that there is a club for us to be supporting in the foreseeable future. In particular, some of the money raised from this Seasons "Quid a Goal" scheme will be donated to the Southend United Centre of Excellence, in particular to the Under 18's as part of our on-going support for SUFC's Youth Team.



This is how it works:

Those who support the scheme with a pledge have their name and details of their pledge displayed in the United match program each week and are detailed on this web site.

We ask you to pledge £0.25, £0.50, £1.00 or more under various headings such as clean sheets, various players scoring goals, or team goals. This does not have to cost you a fortune as you can easily judge in advance how much your pledge will cost you come the end of the season.

For example, the Blues rarely manage more than 80 goals in a season from 1st team matches. A £0.25 per goal pledge would therefore most likely not cost you more than £20.00 come the end of the season. If funds are tight how about £1 for every goal scored by our full backs? The 08/09 season would have cost you £3.00. If you chose to do £0.50 per point and we finished up with 80 points. At the end of the season we will write to you thanking you for your support of this initiative and asking you to send us a cheque for the amount of £40.00.

Last year this scheme raised more than $\pounds 2,000$ from the 60+ people that helped us. This includes support by some of the Southend United's directors.

I'd firstly like to welcome everybody back to Roots Hall and I hope you all had a happy and healthy summers break, it seems to have flown by with Euro 2012 and The Olympics in London, along with our pre-season schedule, it seems sport has not stayed away!

I think our pre-season campaign was rather mixed emotions. Obviously everybody would like to win every game they take part in, but we all know that pre-season is about getting game time under your belt and getting fit. The standard of opposition we faced was much greater than previous years and even though the West Ham game came much too soon for us, throughout the rest of pre-season we competed against Championship teams as well as a decent display on our Madrid tour. The defeat to Spurs doesn't need to be mentioned! However, their young players look a fantastic bunch of talented individuals and the future for Tottenham Hotspurs does look bright.



That then brings us to the first official game of the season, Peterborough away in the Capital One Cup. After setting off in a minibus and sitting in traffic for what seemed an eternity, we arrived at the ground and had a nice lunch in TGI Friday's, washed down with a few pints of lager, then onto the game.

The first half was a very poor game if the truth be told and it was a typical bottom division game. However, the second half came to light and we twice took the lead, before being pegged back and eventually falling behind before Cresswell lashed home a 95th minute equaliser to send The Blues off with their first point of the season.
